**NOTICE TO DEFENDANT OF COURT REQUIREMENTS AND
AGREEMENT AS TO THE SAME**

Below are the Requirements for the Youthful Offender Drunk Driving Program which must all be completed by: _____

You must show proof to the YDD Coordinator 7 days before the above review date - Remember to show proof to coordinator 7 days BEFORE review date.

1. **DUI School** - As required by substance abuse assessment - can be 10 hrs or 24 hrs depending upon what the assessment recommends.
2. **Youthful Drunk Driving Program (YDD)** Call YDD Program TODAY at (918) 588-8433

NOTICE: It takes the entire 120 days to complete the YDD Program which schedules something for you to do for 1 hour at least **once per month**. When and if you show up late for **one** scheduled thing, then you will NOT get credit and you will have to reschedule the matter which may be outside the 120 days and then the court may put you in jail without bond for 7-14 days as a **sanction** for not completing everything within 7-14 days. For example, one person showed up 5 minutes late and they did not get credit and did not finish within 120 days and then the Judge put them in jail for 7 days as a sanction. After the 7-14 days they let you out of jail and order you to complete the YDD program. It could be very easy to be 5 minutes late and then end up going to jail for 7-14 days because you could not find a parking space or got lost or otherwise had some problem. The system is sometimes unfair to people so you will want to assume that you

need to be there at least 30 minutes early for anything since you can go to jail for 7-14 days if you are late.

DO NOT BE LATE. DO NOT WAIT TO CALL. BE ON TIME .

YOU MAY GO TO JAIL FOR **7-14 DAYS** IF YOU FAIL TO COMPLETE THE YDD PROGRAM WITHIN 120 DAYS FROM TODAY.

YDD Program consists of the following: (Orientation)

- I. Emergency room visit - 1 hour
- II. Rehabilitation center visit - 1 hour
- III. Victim impact panel - 1 hour
- IV. Funeral home tour - 1 hour
- IIV. 500 word essay summarizing your experience

Proof of ALL of this must be given to YDD Coordinator 7 days before review

3. \$100 Court Fund + \$100 VCA (\$200) due by 120 day review date.

*If **SUCCESSFUL** on **120 day Review Date**: YOU MUST APPEAR WITH PROOF ON 120 DAY REVIEW DATE then you will be sentenced to 6 months deferred + court costs (\$800+other) with 6 months to pay

On the **6 month review date** if you are still successful then the court will DISMISS THE CASE AND EXPUNGE THE CONVICTION. You will still have an arrest on your record but it will show it was DISMISSED and no conviction.

If unsuccessful after 1st 120 day review, then **7-14 days in Tulsa County Jail** and still complete the YDD program upon release.

If successful (you do everything 2nd) after the next review date then 1 year deferred +costs +\$500VCA = vca increases +DA supervision

If unsuccessful on 2nd or 3rd attempt then sentencing by the Judge up to 1 year in Jail.
